Nichols moved and Mater seconded that warrants #144626 thru #144973 be approved for payment. Ayes all.

Mater moved and Nichols seconded to accept and file the Marion County Treasurer's FY 04/05 Semi Annual Report. Ayes all.

Mater moved and Nichols seconded to approve the following Resolution:

Whereas, the Marion County's outstanding warrant list is showing a number of outdated warrants, a list of which is attached, and

Whereas, these checks have not been redeemed, and

Whereas, warrants from various funds date up to December 31, 2003,

Therefore Be It Resolved, that these checks be voided under the guidelines set forth by our software providers and the funds placed back in the fund balance in the amount shown. Ayes all.

After an overview by Sara Bixby, South Central Solid Waste Agency Director, Mater moved and Nichols seconded to approve the following Resolution:

The Purpose of this resolution is to approve the "Local Government Guarantee" as one of several financial assurance mechanisms for the South Central Iowa Solid Waste Agency.

Whereas, Section 455B.306 of the Code of Iowa requires financial assurance instruments for all sanitary disposal projects; and

Whereas, the Iowa Department of Natural Resources has adopted Chapter 567 111 of the Iowa Administrative Code, promulgating rules for financial assurance instruments; and

Whereas, Chapter 567 111.6 provides for the "Local Government Guarantee" mechanism to be an acceptable financial assurance instrument; and

Whereas, Marion County agrees that if the South Central Iowa Solid Waste Agency fails to perform closure or postclosure care in accordance with the appropriate plan or permit whenever required to do so or fails to obtain alternate financial assurance within 90 days of intent to cancel, Marion County will perform or pay a third party to perform closure and/or postclosure care or establish a standby trust fund in the name of the South Central Iowa Solid Waste Agency or obtain alternate financial assurance; and

Whereas, Marion County meets the requirements of the Iowa Administrative Code 111.6(8),

It Is Hereby Resolved By Marion County and The South Central Iowa Solid Waste Agency that it is in the best interests of the South Central Iowa Solid Waste Agency that financial assurance for closure and postclosure care, as is required by Chapter 111 of the Iowa Administrative Code be met through a "Local Government Guarantee" in the amount of \$44,388 made by Marion County in conformance with Section 111.6(8) of the Iowa Administrative Code.

This guarantee will remain in force unless Marion County sends notice of cancellation by certified mail to the South Central Iowa Solid Waste Agency and to the Department of Natural Resources. Cancellation may not occur, however, during 120 days beginning on the date of receipt of the notice of cancellation by Department as evidenced by the return of receipt. Ayes all.

Mater moved and Nichols seconded to approve Elected Official staff salary adjustments. Ayes all. A list is available in the Auditor's Office.

Nichols moved and Mater seconded to approve a liability agreement between Marion County and the Veteran's Administration Police to use the Marion County Firing Range. Ayes all.

Nichols moved and Mater seconded to approve the following Resolution:

Resolution fixing the time and place for receiving and canvassing bids and considering and passing a resolution for the award of \$5,100,000 General Obligation County Law Enforcement Center Bonds, Series 2005, and providing for the advertisement of such sale.

Whereas, the Board of Supervisors of Marion County (the "County") has heretofore proposed to contract indebtedness and issue \$5,100,000 General Obligation County Law Enforcement Center Bonds, Series 2005 (the "Bonds"), to provide funds to pay the cost, to that amount, of constructing, furnishing and equipping a new Law Enforcement Center, and has called a special County election to vote on the question of issuing the Bonds, at which election the proposition was adopted by a vote in favor equal to at least 60% of the total votes cast for and against the proposition; and

Whereas, the County desires to offer the Bonds for public sale at this time and to provide for the advertisement of such sale;

Now, Therefore, It Is Resolved, by the Board of Supervisors of Marion County, Iowa, as follows:

Section 1. Sealed bids for the purchase of the Bonds shall be received and canvassed on behalf of the County at 10:00 o'clock a.m. on the 23rd day of February, 2005, at the Marion County Courthouse, Knoxville, Iowa, and the Board shall meet on the same date at 12:00 o'clock noon at the Marion County Courthouse, Knoxville, Iowa, for the purpose of considering such bids received and considering and passing a resolution providing for the sale and issuance of the Bonds.

Section 2. Pursuant to Section 75.14 of the Code of Iowa, this Board hereby authorizes the use of electronic bidding procedures for the sale of the Bonds through Parity, and hereby finds and determines that the Parity competitive bidding system will provide reasonable security and maintain the integrity of the competitive bidding process and will facilitate the delivery of bids by interested parties under the circumstances of this bond sale.

Section 3. The County Auditor is authorized and directed to publish notice of said sale, as provided by Chapter 75 of the Code of Iowa, in substantially the following form:

Sealed Bidding: Sealed bids will be received at the Marion County Courthouse, Knoxville, Iowa.

Electronic Internet Bidding: Electronic internet bids will be received at the Marion County Courthouse, Knoxville, Iowa, and must be submitted through Parity.

Electronic Facsimile Bidding: Electronic facsimile bids will be received at the Marion County Courthouse, Knoxville, Iowa, and will be sealed and treated as sealed bids.

After the deadline for receipt of bids has passed, sealed bids will be opened and announced, and electronic internet bids will be accessed and announced. All bids will be presented to the Board of Supervisors for consideration at its meeting to be held at 12:00 o'clock noon on February 23, 2005, at the Marion County Courthouse, Knoxville, Iowa, at which time the Bonds will be sold to the best bidder for cash.

The Bonds will be issued as fully registered bonds in denominations of \$5,000 or any integral multiple thereof, will be dated March 15, 2005, will bear interest payable semiannually on each June 1 and December 1 to maturity, commencing December 1, 2005, and will mature on June 1 in the following years and amounts:

*The County reserves the right, after bids are opened and prior to award, to increase or decrease the principal amount of the Bonds maturing in 2006 and 2024. Any such increase or decrease will be made in multiples of \$5,000, and the total principal adjustments will not exceed \$140,000. The total principal amount of the Bonds issued will remain \$5,100,000. The purchase price will be adjusted proportionately to reflect any change in the principal maturities.

The right is reserved to the County to call and redeem the Bonds maturing in the years 2014 to 2024, inclusive, in whole or from time to time in part, in one or more units of \$5,000, on June 1, 2013, or on any date thereafter prior to maturity (and within a maturity by lot), upon terms of par and accrued interest.

Bidders must specify a price of not less than \$5,031,201, plus accrued interest. The legal opinion of Dorsey & Whitney LLP, Attorneys, Des Moines, Iowa, will be furnished by the County.

A good faith deposit of \$51,000 is required and may be forfeited to the County in the event the successful bidder fails or refuses to take and pay for the Bonds.

The Bonds are being issued pursuant to the provisions of Chapter 331 of the Code of Iowa and will constitute general obligations of the County, payable from taxes levied upon all the taxable property in the County without limitation as to rate or amount.

In order to permit bidders for the Bonds and other participating underwriters in the primary offering of the Bonds to comply with paragraph (b)(5) of Rule 15c2-12 promulgated by the Securities and Exchange Commission under the Securities Exchange Act of 1934 (the "Rule"), the County will covenant and agree, for the benefit of the registered holders and beneficial owners from time to time of the outstanding Bonds, in its continuing disclosure certificate, to provide certain specified information, if customarily prepared and publicly available, and notice of the occurrence of certain events, if material. The County is the only "obligated person" with respect to the Bonds within the meaning of the Rule and, giving effect to the issuance of the Bonds, there will not be more than \$10 million in principal amount of municipal securities outstanding on the date of issuance of the Bonds as to which the County is an obligated person (excluding municipal securities exempt from the Rule under paragraph (d)(1) thereof). A description of the undertaking is set forth in the Official Statement. Failure of the County to enter into an undertaking substantially similar to that described in the Official Statement would relieve the successful bidder of its obligation to purchase the Bonds.

Bidders should be aware that the official terms of offering to be published in the Official Statement for the Bonds contain additional bidding terms and information relative to the Bonds. The Marion County Board of Supervisors met for a special session March 25, 2005, with Howard Pothoven, Dwight Mater Jr., and Sam L. Nichols present. Chairman Pothoven opened the meeting at 10:00 A.M. The following are minutes of the closed executive session portion of the special session.

Executive Session:

Chairman Pothoven gave the floor to Betty Moll, Marion County CPC.

Moll gave an explanation to the Board regarding the decision she had made regarding County funding on behalf of the applicant, Jeff Bradshaw. Betty indicated that she decided to stop funding the applicant at his current level and location. She decided to fund Bradshaw at a PMI with a higher level of care including more expense to the County based on the information she had received.

Jack Holveck, applicant's legal counsel, began questioning Moll regarding Lisa Liston, Bradshaw's caseworker. David Wells, Lisa Liston's DHS Supervisor, responded to the questions. He indicated Bradshaw had requested a new case manager on two different occasions. David was unwilling to change caseworkers within his control has they would recommend the same care as Liston. He did indicate he was willing to move Bradshaw to Adams, Taylor, and Union Case Management if they would have room to accept Bradshaw.

Holveck questioned Moll regarding her comments of "documented problems" with Bradshaw. Moll responded the information she referred to came from Liston's case manager's reports and there was no direct documentation from Megellion.(??)

Holveck asked if the new level of care would be more expensive to the County than Bradshaw's present funding. Moll responded yes. Discussion was held between Holveck, Wells, and Moll regarding different processes of funding.

Moll introduced Bradshaw's case file to the Board.

Holveck and Wells discussed the meaning of "voluntary basis of care". David agreed that Bradshaw would have to accept/agree to his services. Holveck questioned if Bradshaw would lose all funding if he refused the new level of care. David indicated that would probably be the case.

Holveck introduced Bradshaw's "outcome achievement plan". He suggested the plan indicated it required voluntary approval.

Holveck indicated that Liston had allegedly told Bradshaw he was under a 3 strike limit and she would pull his funding. Wells indicated Liston would not have the authority to pull Bradshaw's funding as that is a County decision.

Holveck questioned Jackie Loomis, Director of the Southwest Iowa Residential Facility (SIRF). He questioned her regarding her duties regarding Bradshaw, her analysis of Bradshaw, and an incident which allegedly occurred between Bradshaw and another client at the facility. She indicated it was her opinion that Bradshaw was complying with everything asked and she couldn't give a professional opinion as she was not a doctor.

Sam Nichols, Marion County Supervisor, asked Loomis if any Law Enforcement had been involved in the incident. Loomis responded there had not been and the compliant was written by the client's mother. She also indicated the alleged victim had approached Bradshaw on several occasions and seemed unafraid of him.

Moll asked Loomis how the staff had responded to the incident and temporary restraining order. Loomis responded with separation of two individuals.

Moll asked Bradshaw how much he was working in shelter care and what he did the rest of the time. Bradshaw responded 2 days and stayed at home the rest of the time. He also said he "understood, did his best, and tried to avoid the other client".

Howard Pothoven, Marion County Supervisor, asked Loomis how she worked directly with Bradshaw and why they were continuing with the temporary restraining order.

Loomis, and Doreen Rusk, Innovative Industries, indicated they believed neither sides attorneys could get prepared to deal with the situation.

Holveck questioned Rusk about her basic duties and involvement with Bradshaw. She indicated that Bradshaw was a "higher functioning" client and was achieving his program goals. She also indicated that Bradshaw had been inconvenienced by the restraining order and the other client had tried to approach Bradshaw on different occasions.

Dwight Mater, Marion County Supervisor, asked who was responsible to hold Bradshaw to the restraining order and who set up Bradshaw's plans and programs. Answer was Liston and previous case worker.

Rusk also indicated the facility had received an unsigned complaint of danger against Bradshaw in January 2005. They separated the two individual workdays at that point.

Bradshaw indicated he would like to continue working at Innovative Industries and in the Creston community.

Moll questioned Loomis about SIRF's billing hours while Bradshaw was home unsupervised. Loomis, Wells, and Moll then discussed funding laws and procedures.

Nichols questioned Bradshaw:

"Did the restraining order hurt or hinder you?" Bradshaw – "yes"

"Do you want to continue and have Marion County help you gain independence?" Bradshaw - "yes"

Mater talked to Bradshaw about the positive input from trained professionals to recommend an increased level of care. Bradshaw responded "I do not believe I need to go into a more restrictive environment to achieve life skills"

Holveck questioned Bradshaw about his basic living situations, education, lack of criminal record, and his level of improvement.

Bradshaw indicated he did not hurt the other client, cared for her romantically, had made friends and a support group in Creston.. Why should he have to do it all over again?

Pothoven asked Bradshaw how many people he knew in Creston when he moved there. "none"

Wells asked Bradshaw if he had talked to his therapist about the recommendations of care. "yes"

Nichols indicated he believed the comments about the "incident" between Bradshaw and the other client should be stricken as they were unable to question the other side of the situation.

Moll questioned Bradshaw about his living situation and arguments with his roommates. Bradshaw indicated he had a couple verbal arguments with his roommates.

Wells discussed with Loomis and Rusk about a prior meeting about Bradshaw's living situation. They all couldn't agree to that meeting.

A statement from Bradshaw's therapist was introduced.

Moll declined to give any closing arguments.

Holveck gave some general closing remarks and thank you's.
