Davis opened the public hearing for Rezoning Petition 2025-939(a) – Request by SBS Enterprises LLC (Scott Bailey) to rezone from A-1; Agricultural to C-A; Commercial Ag on Parcel 1329201000.

Poffenbarger presented Rezoning Petition 2025-939(a) – A request from SBS Enterprises LLC (Scott Bailey) to rezone from A-1; Agricultural to C-A; Commercial Ag on Parcel 1329201000 to allow for conversion of existing grain building to a party barn with overnight sleeping accommodation in the loft (cabin). The request for an event space with cabin requires C-A; Commercial Ag zoning per 55.24 (2) Recreation – Public and private event centers, banquet halls, party barns, cabins. The structure will be 30' x 40' with the addition of a kitchen, pantry, restrooms, and storage. The space will be able to serve 75-100 people for family gatherings and celebration events (weddings, graduations). County Engineer approved. Approximately 4 miles of gravel road. Intend to use it for family and as a rental. Not set days or hours. Request to be C-A Restricted for community event space only. One neighbor, Teresa Van Vliet, stopped in office to express concerns.

Davis asked if any public wanted to speak. Mr. Bailey stated the venue will probably not be used more than twelve times per year over the next 5-10 years.
