SE Cor. SW 1/4 NE 1/4- Found 5" x 8" pointed sandstone on south side of long-standing corner post.

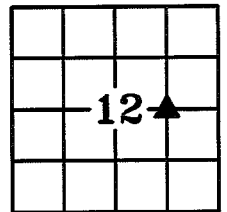

This corner was used for a survey in the NE 1/4 of Section 12.

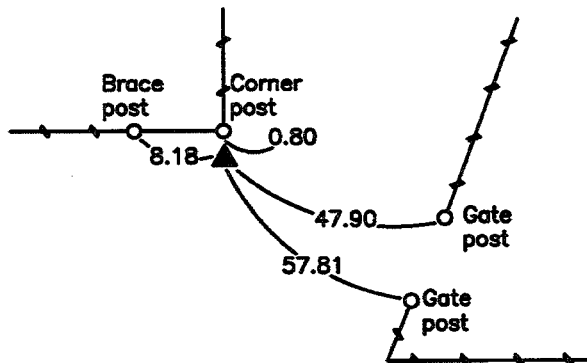
PLAN VIEW
