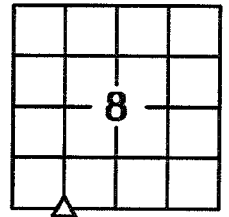
MONUMENT DESCRIPTION & REMARKS

SW Cor. SE 1/4 SW 1/4 - Corner referenced on unrecorded 1975 plats by P.L.S. #4521. Searched area and found ancient corner post to the north with fence line north. Position fit calculated position from said plats within reason. Accepted corner post as best evidence and set 5/8" x 18" pink plastic capped rebar, P.L.S. #22291, on line between SW Cor. & S 1/4 at intersection of said fence north. No certificate of record. This corner was used for a plat of survey in Section 8.

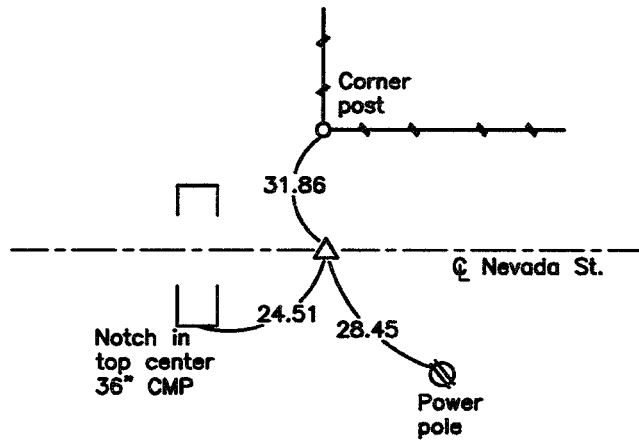
PLAN VIEW
